## ASTHMA

Having difficulty breathing, experiencing tightness in your chest, or have you been wheezing (a whistling sound when exhaling)? You may be one of the millions of Americans diagnosed with asthma, a chronic disease that impairs or makes your breathing difficult. Asthma can occur at any age, however, if you have a family history of asthma or suffer from allergies you may be at greater risk. When an asthmatic person's body comes in contact with a trigger such as tobacco smoke, strong odors from cleaning solutions, pollen / mold spores, or sudden changes in the weather, their airway or bronchioles become obstructed (air cannot move freely),

inflamed (swollen), and constricted (narrow). If left untreated, asthma can be life-threatening and even fatal. There are several treatment options available. Here are some examples of the most common medications used: inhaled steroids (anti-inflammatory) help prevent asthma by decreasing the swelling and mucous production in the bronchioles. Bronchodilators, they relax muscles in the bronchioles and keep the airways open. Oral steroids are given temporarily to relieve a severe attack. If you experience any of these signs and symptoms or have any questions regarding your asthma, speak with your health care professional.

## THE TAX PENALTY FOR NOT HAVING HEALTH INSURANCE COVERAGE IN 2014

The “Individual Mandate” of the Patient Protection and Affordable Care Act (ACA) will require non-exempt individuals and families in 2014 to have health insurance coverage or pay a tax penalty when they file their 2014 federal tax returns. As reported by the Kaiser Family Foundation, the penalty will be \$95.00 per adult and \$47.50 per child (up to \$285.00 for a family) or 1% of the family income, whichever

is greater. In 2015, the penalty significantly increases and increases again in 2016. ## \$\$\$ FOR COLLEGE IS A CLICK AWAY

Apply for bleeding disorder scholarships that apply to you.

Are you planning to attend college or a technical school in the fall? Now is the time to apply for scholarships. Start with a search for bleeding disorder scholarships and then narrow it down to any that apply to you. The National Hemophilia Foundation at [www.hemophilia.org](http://www.hemophilia.org) and the Hemophilia Federation of America at [www.hemophiliafed.org](http://www.hemophiliafed.org) have an extensive list of scholarships for people with bleeding disorders. Most scholarships ask for a reference letter from a non-family member. This could be a teacher, coach, church youth leader or scout leader. Once you get a letter, make copies and use it for any of the scholarships

you apply, that way you won't have to go back and ask for another one. Your guidance counselor's office is a great place to find local scholarships to apply for. Many community groups have scholarship programs. When applying for scholarships, most colleges will ask you to write an essay. For ideas on your essay, think how your bleeding disorder has affected you and your family, how you have overcome challenges, and how you became a young adult while living with a bleeding disorder. The most important step is to start applying. You never know what you'll get unless you apply. Good Luck!

## CORIFACT

Corifact is a factor 13 concentrate used to treat factor 13 deficiency in both adult and pediatric patients. It is administered as a slow IV push at a dose of 40 IU/ kg every 28 days. So a patient who weighs 120 lbs or 55 kg would require a dose of 2,200 IU every 28 days. Corifact is manufactured by CSL Behring from pooled human plasma and comes as single use vials of 1,000 IU to 1,600 IU with 20 ml of sterile water for injection. Currently, there is no recombinant form of factor 13 available. As with other plasma derived products, there is a theoretical risk of transmitting viruses such as CJD (Creutzfeldt-Jakob Disease) and is contraindicated if an individual has had a severe systemic reac-

tion to other plasma products. However, CSL Behring uses a 4 step process to inactivate and removes viruses. Although rare, there are reports of patients developing an inhibitor to Corifact. Factor 13 deficiency is very rare. NHF estimates that it occurs in anywhere from 1 in a million to 5 in a million births. That would mean that in a country with 330 million people like the US, there could be anywhere from 66 to 330 affected individuals. Corifact represents a significant advancement in the treatment of these individuals who previously had to be treated with fresh frozen plasma or cryoprecipitate. ## “BIOSIMILAR” LEGISLATION

The Biological Price Competition and Innovation Law (BPCI) under the Patient Protection and Affordable Care Act (ACA), allows the FDA to develop an abbreviated approval system to license a “biosimilar” product as “interchangeable” with a specific, brand-name biological. The goal of this federal legislation is to lower the price of biological pharmaceuticals to patients and healthcare payers. Concerns expressed by bleeding disorder advocates surround the fact that “interchangeable” does not mean “exactly the same”. In anticipation of when the FDA will begin approving “biosimilars”, some states are currently considering legislation to prohibit automatic substitutions by providers. ## VISITING COLLEGES? HERE ARE SOME QUESTIONS TO ASK...

Attending college is a big transition in your child’s life and the sooner you start planning, the better the outcome will be. Here are some questions that you may want to ask your child, potential college, or Hemophilia Treatment Center (HTC):

- How will your child deal with his or her bleeding disorder at college?
- Who in your child’s dorm should know about their bleeding disorder?
- Have you started letting them place their order for factor and supplies?
- Where will they store their factor and supplies at college?
- Where will their factor be delivered at college?

- What is the college’s policy on sharps containers?
- Does the student health center offer nursing support for venous access?
- If there is an emergency, who does your child contact?
- Does your HTC send a letter to the college health center?
- If your child is going to college outside of your home town, does your HTC allow a nearby HTC know of your child’s attendance at that college?
